On April 4, 2014 I had the opportunity, along with Allan Mills, OASIS Vice President Executive Director, to attend a presentation by Minister Ted McMeekin where funding to address growing waitlists in the developmental services sector was announced. The proposed funding includes an \$810 million investment over the next three years, the largest ever funding increase to the developmental services system in Ontario. Immediately following the announcement OASIS issued a press release over the Canada Newswire (CNW) thanking the Government for this critical investment. We will continue to work on behalf of our membership to ensure the proposal receives support from all three parties.

As many of you know, The Disability Network (TDN) has been awarded a Canadian Radio-Television and Telecommunications Commission (CRTC) license to operate a 24 hour television network with a mandate to inform, educate, entertain, advocate for, and employ persons with disabilities. This will be the 1st station of its kind in Canada, and we have a unique opportunity to represent the voices and opinions of persons with disabilities that for far too long, have been underrepresented throughout society.

We need you to help us make this network successful. We need your ideas with regards to the kind of programming we should offer. We must stand high atop the dial for those with disabilities, to ensure we create a line up of shows that do what we say....inform, educate, entertain, advocate for and employ our community. Your opinion matters to us. We will not only hear, but we will 'listen' and our content will reflect the type of television you want to watch.

We have a short survey we want to have circulated throughout the disability community. We are hoping to reach the widest audience of groups, charities, community organizations and tens of thousands of individuals whose voices need to be heard, and heard loudly.
