Message from the President

We had the pleasure of hosting MCSS ADM Karen Chan at our recent OASIS Board meeting and subsequent dinner engagement. We had a series of questions that the Board had prepared prior to the meeting but as you will well imagine, the hot topic of the day was the matter concerning community employment for people with an intellectual disability. We shared with ADM Chan the amazing work being done in the USA by The Association of People Supporting Employment First (http://apse.org/), their recent conference having been attended by OASIS VP Michelle Marshall, Christian Horizons Area Manager Irene Moore and Ontario Disability Employment Network (http://odenetwork.com/) Executive Director Joe Dale, all of whom were significantly impressed with the progress being made by APSE in over 35 states. It was felt that they were perhaps a little farther along in this area than we are here in Ontario but we are fast gaining ground. That being said, MCSS is not insensitive to the needs of local communities where the potential for home-grown employment does not exist nor is there a specific time table wherein they are committed to ending other options outside of employment. Their investigations in this area span all of Canada from B.C. to Newfoundland, as to how other jurisdictions are dealing with this matter and in the fullness of time, they will craft a policy that is Ontario made and that meets the needs of our communities.

Mergers and amalgamations managed to be squeezed into our discussions from the list of previously prepared questions and ADM Chan indicated that there was no formal policy in place regarding this matter and no specific direction to actively pursue this course of action. However, where a Board of Directors believes that there may be some advantage to considering these options, MCSS will offer whatever assistance they are able, to facilitate change.

MCSS is aware that up to 100 contracts are coming up for renewal with our two main unions in 2016 and at this point in time, there is no specific plan for MCSS to be directly involved in negotiations. However, that does not mean that the unions may not try to involve them in one way or another. Bottom line is that all of the money available for wage increments from within the \$810M three year commitment to the sector, has been allocated.

As the time appointed for our meeting was limited and mostly consumed by the matter of the employment question, the last question that could be asked from our list was with respect to continuing to strengthen agencies. Parents who are now 80 to 90 years of age finding themselves no longer able to care for their children, do not want them to be placed inappropriately in Long Term Care facilities and are fearful that there are no plans for MCSS to make allowances for their loved ones and ensure that they are placed with an agency that can facilitate accommodation and suitable supports. ADM Chan acknowledged that MCSS was aware of this pressing issue and that they would deal with the matter on a case by case basis.

The OASIS Board of Directors extends their sincere appreciation to MCSS ADM Chan for attending our meeting and being prepared to respond to our questions in a forthright, honest and direct manner.

The next meeting of the OASIS Board of Directors will take place on January 13-14, 2016 in Hamilton. As always, members are welcome to attend Board meetings.
