Message from the President

In our recent meeting with ADM Karen Chan and Director Sal Marrello, it was made abundantly clear that MCSS is fully committed to expanding their presence in our communities to provide assistance as the new funding rolls out and changes to Passport are introduced. As you are no doubt aware, regional meetings are being scheduled around the Province to help agencies prepare for the changes that are coming. In addition, OASIS is planning for a late fall, early winter 2014 consultation in order to share with our members how you may best organize yourself and your agency for the impending changes. Our expectation is that MCSS will participate and that valuable information will be shared therein, enabling you to take advantage of the many opportunities that will be forthcoming.

Change is inevitable and how we do business as agencies is about to change drastically over the next few years. In order to respond to the needs of our communities, it will be necessary for us to more actively market our services and supports. We will need to reach further into the community than we have ever done before and we will need to develop mutually beneficial relationships with the Regional DSO that places agencies in the forefront of available service providers. We have the training, the accreditation, the quality control, the health and safety standards and the commitment to the people we support to enable them to achieve the best possible outcomes.

You do not need to go through this alone. Agencies should, as they have previously, turn to their peers, colleagues and associates in their region to investigate their collaborative capacities, celebrate their leaders of change, and draw upon the facilitators and/or assistants who can help in the creation of networks. All of which will help meet the demands of a new system responsive to the continuation of the transformation of services and the introduction of the new funding mechanisms. This could include menus of service, billing systems, marketing materials and social media exposure that would create a level playing field for all partners in your community and a potential single point of access for families to choose the service and/or supports that best meets their needs. You are only limited by your imagination, as to what will work best for your agency.

We at OASIS expect to consult with you our members to find the best means possible to continue to build strong, resourceful, effective and efficient agencies. We will do this by investigating and sharing with you any opportunities and all options that present themselves.

The next meeting of the OASIS Board of Directors will take place on October 29-30, 2014 in Woodstock. As always, members are welcome to attend Board meetings. We welcome you
