OASIS Go Local Campaign

Cameron MacKay Senior Vice President – Public Affairs Lead from Edelman joined the Board for this discussion. OASIS continues to work on a multi-jurisdictional grass roots initiative to engage our member agencies in an advocacy campaign that will help unify and strengthen the voice of our sector. On October 4, 2017 OASIS held a webinar to update Phase 2 lead agencies on group activities since our Think Tank in June 2017. The webinar, reviewed the new pillars, Go Local Toolkit, and preparations for Queen's Park Day agenda.

To build on messages shared at the OASIS Queen's Park Information Day and Provincial Network Communication Strategies implemented at the recent MCSS Regional Engagement meetings, The Provincial Network on Developmental Services, Community Living Ontario and OASIS have come together

to unify and strengthen our voices. In consultation with the Provincial Network, OASIS has agreed to take the lead in developing a comprehensive communication campaign that will raise awareness of the Crisis of Developmental Service Agencies and call for immediate action. The OASIS Labour Relations Committee and the Provincial Network will be co-hosting an Information Forum on November 22, 2017 to update you on the work that has occurred since the July 5th Forum and introduce you to the key messages and unified ASK foundational to this multi-faceted campaign. To participate in this Campaign, YOU will be asked to use traditional and social media tools to help all of us push this up the agenda of Ontario's top political parties. The goal of this initiative is to work together as a cohesive sector that will help raise awareness of the immediate and long-term funding commitments required to ensure that people with disabilities have access to the services they need for their health, wellness, and access to their community. We know that together our voices are more powerful.

Queen's Park Day

On October 19, 2017, OASIS held its third annual information day at Queen's Park. It is an opportunity to educate policymakers about the challenges facing the developmental services sector, our member agencies, their employees, and the families we work with every day. Conversations focused on the issues facing the sector including the nine years of base budget freezes, unfunded liability of pay equity, waiting lists and Bill 148. We also discussed need to address a long-term strategy to provide adequate funding to the sector that gives consideration to cost of living increases on an ongoing basis. In addition, we recommended that the Ministry become more proactive in providing supports to people on the wait list with lower support needs reducing the risk of family breakdown or crisis

which may reduce the economic impact and significantly reduce wait lists.



The day was a huge success that included a question being asked during Question Period by MPP Randy Pettapiece to Minister Jaczek on behalf of OASIS and a lunch reception that was attended by a number of Cabinet Ministers, MPPs from all parties, public servants. A few member agency representatives, Bob Butella, ED Sunbeam Centre, Nancy Wallace-Gero, ED Community Living Essex County and Trevor MacGregor, ED Community Living Stratford attended Question Period and our lunch reception.



Ann Kenney, Michelle Marshall and Darren Connolly also had a successful meeting with the Janet Menard, Deputy Minister and Rupert Gordon, Assistant Deputy Minister on October 18, 2017.

The Board looks forward to continuing our dialogue regarding the immediate and long-term investments needed for community agencies and working with government to ensure the protection of our community agencies.

Bill 148 Media Release

On October 30, 2017, a <u>Media Release</u> was developed in collaboration with Community Living Ontario and Provincial Network. The release focused on the estimate that the Ontario Government's Bill 148, will divert an estimated \$55 million away from direct service provisions for people with developmental disabilities. Following the circulation of our media release, we initiated a social media campaign (<u>Twitter</u> and <u>Facebook</u>) to raise awareness of this very important issue, that if implemented will have a significant negative impact on the Developmental Services Sector. We asked colleagues to share this release and we have experienced a record-breaking response from the sector and our supporters. Thank you to all that shared our message and release.



Standing Committee on Finance and Economic Affairs

During our Board meeting on October 26, we received notice that the Standing Committee on Finance and Economic Affairs intended to hold public hearings in Toronto between Monday, October 30, 2017 and Thursday, November 2, 2017.

The Board is pleased to confirm that OASIS was successful at securing a spot on the <u>October 30 agenda</u>. David Ferguson attended and relayed our recommendation that the Committee, and the Government consider a slower implementation timeline for the minimum wage increases. We also sought a commitment from Government, to fiscally support OASIS member agencies, & other not-for-profit organizations that are dependent upon Government funding, by funding the cost increases that will arise from Bill 148's provisions. David highlighted that agencies cannot absorb the additional costs of Bill 148 without there being a further erosion of the Developmental Services system in Ontario. The presentation also highlighted the possible ramifications of Bill 148 on developmentally disabled individuals who have obtained jobs.

Labour Relations Committee/Operating Pressures Survey

The DSAG subcommittee met concerning Picketing Protocols. Members of the Labour Relations Committee also met with Rupert Gordon, ADM on October 23, 2017. They had an informative meeting that covered various items such as but not limited to: the history of the committee, DSAG, the compensation study, Picketing Protocol, Dynamics of Ministry interference during recent strike, Operating Pressures Survey, Bill 148, Bill 145, Pay Equity, DSPDT and workforce stability and the Executive Salary leak.

The Board reviewed the Operating Pressures Survey. The survey was launched on August 18 and was distributed throughout the DS sector and gathered information regarding agency financial pressures, plans for managing these costs and the impact on the supports and services being provided. This information will be utilized in ongoing efforts to advocate for additional funding and changes for the DS Sector. The outcomes and statistics consolidated through this survey were used to anchor our conversations during the OASIS Queens Park Information Day, as well as, all key messages used during the Go Local Campaign and other strategies. Thank you to all who have taken the time to complete the survey to date. Together our voices are stronger. The survey results will be distributed Nov. 20, 2017.

OASIS 2020 - Strategic Goals and Priorities

The Board reviewed a report and implementation plan for OASIS 2020. Committees will be working on terms of references and current and future work plans to ensure they align with the OASIS 2020 strategic goals and priorities. They will report back to the Board at the December board meeting at which time the implementation plan will be approved and a report will be shared with member agencies and other stakeholders. We continue to collaborate with all stakeholders – our members, our partners, and government ministries – to discuss our value and our shared future supporting people with special needs in Ontario.

Ontario Brain Institute (OBI)

On September 27-28, 2017, Darren Connolly participated in Canada's first Neurodevelopmental Disorders Priority Setting Partnership. <u>OBI</u> asked people living with neurodevelopmental disorders, their families, carers, and health/education professionals how research can best meet their needs.

They received 1200+ questions from the community and worked with the group to rank which questions were most important. Here are the priorities from the neurodevelopmental disorder community Top 10 research questions for neurodevelopmental disorders. OBI is a provincially funded not-for-profit research centre maximizing the impact of neuroscience and establishing Ontario as a world leader in brain research, commercialization and care.
