2013 Provincial Budget

OASIS extended congratulations to Premier Kathleen Wynne and the Liberal Government on recognizing the needs of Ontarians with developmental disabilities and their families in the 2013 Provincial Budget. The budget was backed by the NDP and passed on June 11th.

While the government is increasing the Employer Health Tax (EHT) exemption to small employers to \$450,000 beginning January 1, 2014, and eliminating the exemption for private sector employers with annual Ontario payrolls over \$5 million, this should not impact most OASIS members. The government did exempt registered charities and they are able to continue to claim the exemption at all payroll sizes. Salary Survey

The fourth salary survey for the Developmental Services sector was released May 3, 2013. Over 300 agencies were invited to complete the survey. The survey collected data from 123 agencies representing all areas of the province. Total reported Ministry revenues exceeded \$936 Million, 55% of the estimated \$1.7 Billion 2012-13 Budget for Developmental Services for adults and children in the province. Fiscal constraints remain a major concern and it was apparent that agencies were struggling to meet increased costs with stagnant or shrinking budgets.
