



By combining services of the two organizations efficiencies in resource allocation, enhanced staff expertise in children services, and improved seamless service delivery to children, youth, and adults with developmental disabilities, autism and/or visual impairment were created.

Even though each amalgamation will have its own unique challenges, the experience will shed light on those common challenges that need to be negotiated carefully when considering an integration project. Specifically, this session will address the key elements to consider when embarking on an integration of two organizations, including a review of financial, human resource, organizational culture and program integration to point out its significance, benefits and challenges. This review can serve as a due diligence check list for other organizations in carrying out similar integration exercises in the future.

#### 7 Your Best Legal Footwear: Understanding the Power of Attorney/Guardianship Issues that Affect Those You Serve

The right to make decisions for ourselves is fundamental and not lightly interfered with. There are times, however, when others must make decisions for us. During such times, the concept of capacity arises. This brings with it a myriad of questions including:

- What is the legal definition of capacity and who decides?
- Doesn't a parent automatically get to make decisions for a mentally incapable child event if that child is 18 years or older? If not the parent, then who?
- If an individual might not have capacity, can they instruct you? If not, then who?

It is often an Attorney (substitute decision-maker) or court-appointed Guardian who makes decisions for someone who cannot make decisions for themselves. To gain a full understanding of the Power of Attorney/Guardianship issues which affect individuals you support, jump in with both feet as the following topics are explored:

- The two types of Powers of Attorney (POA's )and how they differ
- The differences between POA and guardianship
- The governing legislation such as *Health Care Consent Act, Substitute Decisions Act*
- Hierarchy of authority (who is called upon to make decisions)
- How decision-making authority changes when a child turns 18 and how to help parents who may be unprepared for the changes
- When a capacity advisor is required
- The duties and responsibilities of a POA/guardian
- Dueling POA's (to whom do you listen?)

The difference between controlled acts that can be taught and controlled acts that must be delegated will be covered along with how the Regulated Health Professions Act defines acts of daily living. We will outline necessary policies and procedures for ensuring provincial guidelines are met and how to advocate for community supports. The session will address the role, responsibility and liability of the teaching professional, the agency, as well as the unregulated care provider who is performing the act. To wrap up the session, a framework for teaching controlled acts and monitoring continuing competencies will be presented along with a look at a standardized training program for controlled acts which has been launched in the Ottawa area.


