This session will introduce the High Performing Community Organization (HPCO) Framework, offering a roadmap to enhance resilience, service delivery, and sustainability. Learn from Community Living Huntsville (CLH)'s proactive approach to building a high-performance culture that prioritizes staff engagement, psychological safety, and operational alignment. Participants will leave with practical strategies and best practices to create a thriving organizational culture in the face of sector transformation.
Breakout Session 3D	3:00 PM - 4:00 PM	Exploring Access and Utilization of Passport Funding: Perspectives of People with the Label of Intellectual Disability and their Families	Presented by Yvonne Spicer from the Successful Advocacy Research Group, this research study investigates the gap between available Passport Funding and the unmet needs of individuals with intellectual disabilities in Ontario. Through a province-wide survey of 422 respondents, including those with intellectual and developmental disabilities, the study reveals key insights on access barriers and the accommodations needed for participation in online spaces. The interim results highlight how many individuals rely on assistance from family members or support workers to navigate these processes. This session will explore how agencies can better support people with disabilities, particularly by improving access to online resources and increasing the utilization of available funding to help individuals live authentic lives.

Attendees will explore how AI can streamline operations, enhance decision-making, and improve service delivery through simple, adaptable solutions—no tech background required. The session will include real-world examples, live demonstrations, and discussions on ethical considerations and data privacy. By the end, participants will gain practical insights on how to customize AI for their roles and confidently integrate it into their work to boost efficiency while keeping people at the center of their services.
