Message from the President

I would like to express my sincere thanks to the 2017 Planning Committee for hosting a wonderful Conference and Annual General Meeting in Ottawa last month. We were proud to have representatives from the six founding member agencies and Past Presidents George Braithwaite, Judy Reid, Jane Joris and David Barber in attendance to help us celebrate our 20th Anniversary at the Thursday evening gala event. I would like to thank Karen Chan for representing the Minister at the Gala Award evening and handing out certificates of congratulations on behalf of the Minister to the Scholarship and Award Winners.

In March OASIS commenced recruitment for an Executive Coordinator Services Consultant. OASIS has grown from an original membership of six (6) agencies to one hundred & ninety (190). During that time, the stature of OASIS as a well-respected provincial organization within the developmental services sector has grown, and so has the workload of the Board of Directors. During OASIS's infancy, member agencies banded together to provide the support necessary to ensure that members were kept up to date on current trends, took an active role in advocating for positive change for the developmental sector with the Government and peers, and being visible to the members. With the growth in membership, it has become exceedingly difficult to carry out the work of OASIS with only volunteers. Given the activities and responsibilities of OASIS, there is now a need to establish consistency of process to ensure that the administrative and communication to member agencies and others are addressed in a different manner. In May, OASIS welcomed Monica Zeballos-Ouiben, as the new Executive Coordinator Consultant, to our fold at the Annual Conference. Monica's primary responsibilities will be to address the needs of our member agencies, addressing OASIS communication needs including the website, and assisting the Host Committees with Conference Planning. The Board of Directors will be meeting the afternoon of June 14th to review the feedback of our member agencies and external stakeholders that will guide the development of OASIS 2020 Strategic Plan. A communication and implementation plan will be developed by the Board of Directors and shared with our members in the near future. Our New Board Members

As with every Annual General Meeting it is a time of transition for the Board of Directors. It is with sadness that we celebrated Donna Britten's last meeting as a member of the OASIS Board of Directors. Donna was a valuable asset to the board bringing her unwavering support for agencies and the voice of parents to our discussions. She will be missed. We also welcome two new additions to our Board.

David McCoy, will join the OASIS Board as a Volunteer representative and is a board member of Reena. David recently retired and has facilitated strategic planning and evaluation processes, and implemented organization development initiatives in the private, public and voluntary sectors. As an executive coach, he has worked with senior professionals in medicine, law, nursing, accounting, financial services, business and government. He has extensive senior management and leadership experience as a Managing Partner in the private sector, a Director in the Ontario government, and an Executive Director in a community not-for-profit organization. Ministry of Labour Announces Plans to Revise Employment Standards Act

Ann Kenney received a telephone call from Karen Chan to advise that the Ontario Government has announced plans to introduce reforms to legislation in the fall that will see significant changes to the Employment Standards Act. If passed these changes may have significant impact on agencies, including g simulated working environments or sheltered workshops. Under the proposed changes, sheltered workshops would no longer be exempt from the Employment Standards Act and if passed will come into effect January 2019. This means the elimination of Sheltered Workshops by that date.

The Ministry of Community and Social Services did advocate to have no date attached to the proposed changes to sheltered workshops but were unsuccessful in their attempts to do so. Karen informed me that MCSS regional staff would be reaching out to agencies to follow-up with more specifics this week.

The OASIS Board will be discussing this at their June meeting, and how OASIS can assist agencies with providing information, training, and advocating member concerns. Please let us know how you may be impacted and areas you would like to see OASIS address on this issue.
