

Separation of provision of housing from provision of supports and services:

- Conflict of Interest
- Differing Responsibilities
- Differing Skill Set
- Improved lines of accountability

Less Reliance on Government

- Provision of affordable Housing with or without Government funding
- Pay down mortgages (with Income from Rent)
- Gain Equity
- Equity used to finance additional housing
- Corporation has control over equity (not government)
- Corporation has control of any surplus (not government)
- Ability to set up appropriate Reserves (for major contingencies)

#### Separate Corporation

- Apply for Non-profit Corporation
- Apply for Charitable status with CRA
- Arms length from support/service organization but connected
- If Housing has 3 directors; 1 from support/service organization
- If Housing has 5 directors; 2 from support/service organization
- If Housing has 7 directors; 3 from support/service organization
- Chair of Housing should be a director of support/service organization
- Members of Housing Corporation are Directors of Corporation

Separate Housing Corporation - consideration needs to be given to:

- Maintenance of homes
- Administration of Corporation
- Insurance of properties
- D&O Insurance
- Establishment of Reserve Funds

**Future Possibilities** 

- Working with families on provision of shelter
- Each project must be financially viable

What are current circumstances:

- Houses owned with MCSS interest?
- Houses owned through Dedicated Supported Housing (DSH) program?
- Houses owned by support/service organization with no Ministry interest?
- Property owned other than Houses?
- Future Plans?

Considerations for the creation of a separate Housing Corporation:

- Unravelling the lines of responsibility and accountability
- Determine role/responsibility of Property Manager
- Determine role/responsibility of Executive Director
- Set up appropriate structure for the future
- Compensation for Administration Finance, Property, and CEO
