Emerging Issues & Collective Bargaining

Rupert Gordon, ADM, MCSS and Christine Kuepfer, MCSS attended the Board meeting on March 1, 2018. The Board addressed various topics as follows:

Coordinated Bargaining:

The Board, Rupert Gordon and Christine Kuepfer had an exploratory discussion concerning coordinated bargaining. The ADM had initiated a similar discussion with the Provincial Network the previous week. The Ministry is of the opinion that some form of coordinated bargaining would improve the sector going forward. The Board raised initial concerns as follows:

-What is driving this initiative? Political (election) vs supporting the sector by fixing the DS model of bargaining

-Short term gaps and risks vs long term solution

-Picketing of people's homes

David Ferguson will continue discussions with the Ministry concerning this topic. The Board will advise members as we proceed with this issue. There was consensus to explore the topic, in a gradual, thoughtful manner that engaged the sector in a consultative manner.

Bill 148 Funding/Budget Submissions:

The Board discussed concerns with the lack of clear information concerning Bill 148 funding, and that agencies are feeling the pressures in more ways than cutting budget lines since it will affect service delivery. As a result, the Board sought clearer messaging that they can provide to member agencies on how to best manage the cost pressures of Bill 148 and budget submissions that are due at the end of





the fiscal year. In particular, they questioned whether agencies should be putting forward 'deficit' budgets or whether they should delay putting forward their budgets. Rupert confirmed that the current funding received for Bill 148 would be annualized at four times the fiscal allotment provided to agencies this past month. Rupert also acknowledged the struggle regarding deficit budget submissions and the timing of the Provincial Budget. He suggested that Executive Directors should have a conversation with their Program Supervisor regarding budget submissions and asked that the Board to advise him on OASIS' recommendations regarding this issue. Rupert was not able to approve the recommendation of OASIS and is to provide further clarity on which can be done.

Pay Equity

The Pay Equity Committee and Christine Kuepfer, MCSS met on Feb 27th. Discussions were productive and they agreed to meet again. The Ministry acknowledged that there had been a moratorium on speaking about Pay Equity but that it was now lifted.

Social Media Campaign/ Go Local Campaign

The final social media graphic from our 2rd series will be posted on Monday March 26. Currently the Communications Committee has begun consultations with Edelman Public Relations to develop content for the 3rd series of graphics. These graphics that will run through the month of April and up until the June election. Visit our Twitter and Facebook pages SHARE our posts.

Thank you to the many agencies that have met with their MPP's and participated in pre-budget discussions. Your efforts have helped to increase awareness and understanding of the four critical issues impacting the developmental services and what this means for the MPP's constituents, their communities and the health of Ontario. The impact related to this is clearly set out within the <u>OASIS 2017</u> <u>Operating Pressure survey</u>.
